VINS & DOMAINES

Famille Piffaut is a family story that dates back 200 years to 1820, when Piffaut ancestor, Charles Ninot, founded a winery in Burgundy. Since then, generation of the family have been involved in the wine business. Fifth generation Eric Piffaut took the reigns and became one of the regions largest vineyard holders. Today, the group is managed by Aurelien Piffaut and is comprised of four wine brands (Veuve Ambal, Rivarose, André Delorme & Prosper Maufoux) and six Domaines (Marie Ambal, Domaine La Vigne au Roy, Domaine André Delorme, Chateau Saint-Aubin, Domaine Gracieux Chevalier), with the Domaines totaling 280 hectares of prime Burgundian estate vineyards.

BURGUNDY

In typical Burgundian tradition, Famille Piffaut is offering a presell on the latest vintage of wines from three producers: Prosper Maufoux, Chateau Saint-Aubin and Domaine La Vigne au Roy. These twenty two wines are primarily from the 2019 vintage and will be offered to the USA wine trade during the month of June for delivery to retail and restaurants in time for the busy holiday selling season. Resulting wines are fresh and aromatic with great complexity due to these high altitudes and calcareous soils.

NADINE GUBLIN

The winemaking is helmed by famed oenologist Nadine Gublin, who oversees the production of the family domaines. Gublin was the first female winemaker of the year named by France's leading wine magazine, La Revue du Vin de France, and has worked with some of the regions best producers.



PROSPER MAUFOUX

In 1860, Prosper Maufoux, who was a notary by trade, left his practice to give his life over to his passion for wine. He set up his own firm in Santenay, a Burgundian village in the heart of the vineyards in southern Côte d'Or. Eric Piffaut purchased the Burgundian house and dedicated new resources into the property to establish high quality and the company's international renown. Today, Prosper Maufoux produces wines from the best climats (areas) of Burgundy with the aim to honor the Burgundian terroirs expression.

CHATEAU SAINT-AUBIN

The estate changed hands several times over the centuries, before eventually being acquired by the Piffaut family. The estate is comprised of 6 Premier Cru and Gran Cru vineyards, located in the Côte de Beaune between Santenay (to the south) and Beaune (to the north), right in the heart of the illustrious Côte des Blancs. They extend over around 30 acres and have the particularity of being exclusively planted with Chardonnay. Their monopole, a rarity in Burgundy, Clos du Chateau sits directly in front of the house and is classified as Saint-Aubin 1er Cru. Winemaking is carried out with minimum intervention, to produce white wines with high level of freshness, energy and tension. The goal is to allow the terroir to achieve maximum expression.

DOMAINE LA VIGNE AU ROY

The Domaine de la Vigne au Roy was purchased by the Piffaut family in 2000. It covers 36 hectares of estate vineyards, planted to 60% of Pinot Noir and 40% of Chardonnay, nestled under particularly well exposed hillsides at an unusually high altitude of 1,575 feet above sea level. This ensures the terroir benefits from a very favorable micro-climate and provides remarkable freshness in the wines produced here, primary a white and red wine under the appellation of Hautes Côtes de Nuits.
